## Prior Approval Form

The National Automobile Dealers Association Political Action Committee (NADA PAC) supports congressional candidates who understand the interests of NADA members and the auto retail industry.

Federal election law prohibits corporations and labor organizations from contributing to federal campaigns and committees. NADA corporate member dealerships must provide NADA PAC with written prior approval before any solicitation may be directed to eligible dealership personnel and families.

*By signing below, I authorize NADA PAC to include the corporate dealership(s) listed below in communications that may solicit funds from me and other eligible dealership executive and administrative personnel and their families for NADA PAC during the calendar year(s) designated below. In granting this authorization, I understand that:*

- This form does not obligate the signer or anyone else at the dealership to donate to NADA PAC.
- Only the Authorized Representative/Dealer Principal on file with NADA may grant prior approval for their NADA member dealership.
- Under federal law, a corporate member of a trade association may not approve a federal PAC solicitation by more than one trade association for the same calendar year. The dealership(s) listed below has not approved a solicitation for any other trade association's connected federal PAC (other than NADA PAC) for the same calendar year. (This authorization does not prohibit dealership personnel from receiving solicitations from or contributing to the Automotive Free International Trade PAC (AFIT-PAC), which is not a connected federal PAC.)
- Only one form is needed per dealership location. The signer may include multiple dealership locations on a single form, if authorized to sign for those dealerships. The signer may grant NADA PAC prior approval for up to five years for each listed corporate dealership by signing above each year listed.
